



# KITSAP BLUEJACKETS PLAYER CONTRACT

Entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ between the parties whose signatures appear below, the first hereinafter known as "Player" the second hereinafter known as "Kitsap BlueJackets Team" and the third being the West Coast League. It is understood between the parties hereto that mutual promises of each party to this agreement shall be full and complete consideration for this contract.

The Player whose signature appears below agrees that he will, for a period following the date hereof, participate for the entire season, including all regular season and post season play as a member of the Kitsap BlueJackets, unless said Player may be released by the Team as hereinafter provided. It is understood that the Player will have remaining collegiate eligibility and adhere to all West Coast League and Team code of conduct policies and represent their team and the community in which the Team resides in a mature and professional manner. The Player understands a breach of the West Coast League or Team code of conduct and rules will be reported to the West Coast League President and will result in action that may include letter to parents, college coach, scouts, other West Coast League affiliated leagues and suspension. Upon receiving said agreement, the West Coast League shall first check Player's eligibility status and then certify him for play. The West Coast League and Team have obtained an accident policy ("Insurance") for the benefit of the Player. This insurance is secondary to the Player's primary insurance, which the Player is expected to have and maintain. By signing this Agreement, the Player acknowledges his awareness of this Insurance. The player may obtain a copy of the policy language by making a request to the West Coast League or Team.

This agreement may be terminated at any time at the will of an authorized team official, and the Player may be released by the Team by drafting and mailing to the West Coast League office a release memo signed by both Team and Player. Upon receipt of said release, the West Coast League will notify said player that he is a free agent by a signed copy of his release. Until player receives a signed copy of said release from the West Coast League, he is not eligible to participate for any other West Coast League Team or in any other summer collegiate wood bat league. The undersigned Kitsap BlueJackets Team representative upon signing this agreement certifies to the said Player and to the West Coast League that no player on Kitsap BlueJackets Team receives any financial remuneration except that which is authorized under NCAA rules. In the event the undersigned player or Kitsap BlueJackets Team representative knowingly violates the intent of this agreement, by becoming affiliated with another West Coast League team without having been properly released from this agreement or signing above player while knowing he is not a legal free agent according to the rules of the West Coast, the Player will be subject by the West Coast League to a suspension levied by the West Coast League President. It's further understood that any West Coast League affiliated team may protest the eligibility of any West Coast League player in his league or any West Coast League sanctioned tournaments. Any team protesting a Player's eligibility must post a \$50 bond at the time of protest. If protest is allowed this bond will be promptly returned.
